# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to krystalgemsart.com, and Krystal Gems Art, LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Krystal Gems Art, LLC include krystalgemsart.com, Krystal Gems Art, new growth collective and krystalgemsart.com. The Krystal Gems Art website is a portfolio and booking site. By using the Krystal Gems Art website, you consent to the data practices described in this statement.

# **Collection of your Personal Information**

In order to better provide you with products and services offered, Krystal Gems Art may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. # **Automatically Collected Information**

Information about your computer hardware and software may be automatically collected by Krystal Gems Art. #### **Use of Cookies**
